2.3. Other hazards (not relevant for classification)

Other hazards not contributing to the classification

: This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels. Any substance, in case of accidents involving pressurized circuits and the like, may be accidentally injected under the skin, even without external damage. In such a case, the victim should be brought to an hospital as soon as possible, to get specialized medical treatment. Do not wait for symptoms to develop. A potential risk may arise from the release of hydrogen sulfide, when the product is stored or handled at high temperature. SECTION 4: First aid measures

First-aid measures after inhalation

: Remove to fresh air, keep the casualty warm and at rest. If breathing is difficult, give oxygen if possible, or assisted ventilation. If necessary, give external cardiac massage and obtain medical advice. See also section 4.3.

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects after inhalation

: Inhalation of fumes or oil mists produced at high temperatures may cause irritation of the respiratory tract. Symptoms of overexposure to vapours include drowsiness, weakness, headache, dizziness, nausea, vomiting, dimming of vision.

Symptoms/effects after skin contact Symptoms/effects after eye contact

Symptoms/effects after ingestion : Accidental ingestion of small quantities of the product may cause nausea, discomfort and

gastric disturbances.

Symptoms/effects upon intravenous administration : No information available.

Chronic symptoms : None to be reported, according to the present classification criteria.

4.3. Indication of any immediate medical attention and special treatment needed

Obtain medical attention if casualty has an altered state of consciousness or if symptoms do not resolve. Seek medical attention in all cases of serious burns. If there is any suspicion of inhalation of H2S (hydrogen sulphide), Rescuers must wear breathing apparatus, belt and safety rope, and follow rescue procedures. Send patient to hospital. Immediately begin artificial respiration if breathing has ceased. Administer oxygen if necessary.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Small-size fires: carbon dioxide, dry chemicals, foam, sand or earth. Large fires: foam or

water fog (mist). These means should be used by trained personnel only. Other extinguishing gases (according to regulations).

Unsuitable extinguishing media : Do not use water jets. They could cause splattering, and spread the fire. Simultaneous use

of foam and water on the same surface is to be avoided as water destroys the foam.

5.2. Special hazards arising from the substance or mixture

Fire hazard : This product is combustible, but not classified as Flammable. The creation of flammable vapour mixtures takes place at temperatures which are higher than normal ambient levels.

Explosion hazard : In case of losses from pressurized circuits, the sprays may form mists. Take into account that in this case the lower explosion limit for mists is about 45 g/m3 of air. Vapours are

heavier than air, spread along floors and form explosive mixtures with air.

Hazardous decomposition products in case of fire : Incomplete combustion is likely to give rise to a complex mixture of airborne solid and liquid particulates, gases, including carbon monoxide, NOx, H2S and SOx (harmful/toxic gases).

Oxygenated compounds (aldehydes, etc.).

5.3. Advice for firefighters

Firefighting instructions : Shut off source of product, if possible. If possible, move containers and drums away from danger area. Spilled product which is not burning should be covered with sand or foam. Use

water sprays to cool containers and surfaces exposed to the flames. If the fire cannot be

controlled, evacuate area.

Special protective equipment for firefighters : Personal protection equipment for firefighters (see also sect. 8). In case of a large fire or in confined or poorly ventilated spaces, wear full fire resistant protective clothing and self-

SECTION 6: Accidental release measures

6.1. Personal precautions, protective equipment and emergency procedures

General measures : Stop or contain leak at the source, if safe to do so. Eliminate all ignition sources if safe to do so (e.g. electricity, sparks, fires, flares). Avoid accidental sprays on hot surfaces or electrical

contacts. Avoid direct contact with released material. Keep upwind.

6.1.2. For emergency responders

Protective equipment

: Standard EN 469 - Protective clothing for firefighters. Standard - EN 659: Protective gloves for firefighters. Small spillages: normal antistatic working clothes are usually adequate. Large spillages: full body suit of chemically resistant and antistatic material. if necessary heat resistant and insulated. Work helmet. Antistatic non-skid safety shoes or boots. Emergency procedures

: Notify local authorities according to relevant regulations.

6.2. Environmental precautions

Do not let the product accumulate in confined or underground spaces. Do not let the product flow into sewers or water courses, or in any way contaminate the environment. In case of contamination of environment compartments (soil, subsoil, surface or underground waters), remove contaminated soil when possible, and in any case treat all involved compartments in accordance with local regulations. The site should have a spill plan to ensure that adequate safeguards are in place to minimize the impact of episodic releases.

6.3. Methods and material for containment and cleaning up

For containment

: Contain spilled liquid with sand, earth or other suitable absorbents (non-flammable). Recover free liquid and waste materials in suitable waterproof and oil-resistant containers. Clean contaminated area. Dispose of according to local regulations. If in water: Confine the spillage. Remove from surface by skimming or suitable floating absorbents. Collect recovered product and other waste materials in suitable waterproof, oil resistant containers. Recover or dispose of according to local regulations. Do not use solvents or dispersants, unless specifically advised by an expert, and, if required, approved by local authorities.

Methods for cleaning up

: Transfer recovered product and other materials to suitable tanks or containers and store/dispose according to relevant regulations.

Other information

: Recommended measures are based on the most likely spillage scenarios for this material; however, local conditions (wind, air/water temperature, wave/current direction and speed) may significantly influence the choice of appropriate actions. Local regulations may also prescribe or limit actions to be taken. For this reason, local experts should be consulted when necessary.

SECTION 7: Handling and storage

7.1. Precautions for safe handling

Precautions for safe handling

: Ensure that proper housekeeping measures are in place. Keep away from heat/sparks/open flames/hot surfaces. Use and store only outdoors or in a well-ventilated area. Ensure good ventilation of the work station. Due to the extremely slippery nature of this material, more care than usual must be exercised in material handling practices to keep off all walking surfaces. Floors, walls and other surfaces in the hazard area must be cleaned regularly. Before entering storage tanks and commencing any operation in a confined area (e.g. tunnels), carry out an adequate clean-up, and check the atmosphere for oxygen content, flammability, and the presence of sulphur compounds. The product may release Hydrogen Sulphide: a specific assessment of inhalation risks from the presence of hydrogen sulphide in tank headspaces, confined spaces, product residue, tank waste and waste water, and unintentional releases should be made to help determine controls appropriate to local circumstances.

Handling temperature Hygiene measures : This product can be handled at ambient temperatures.
